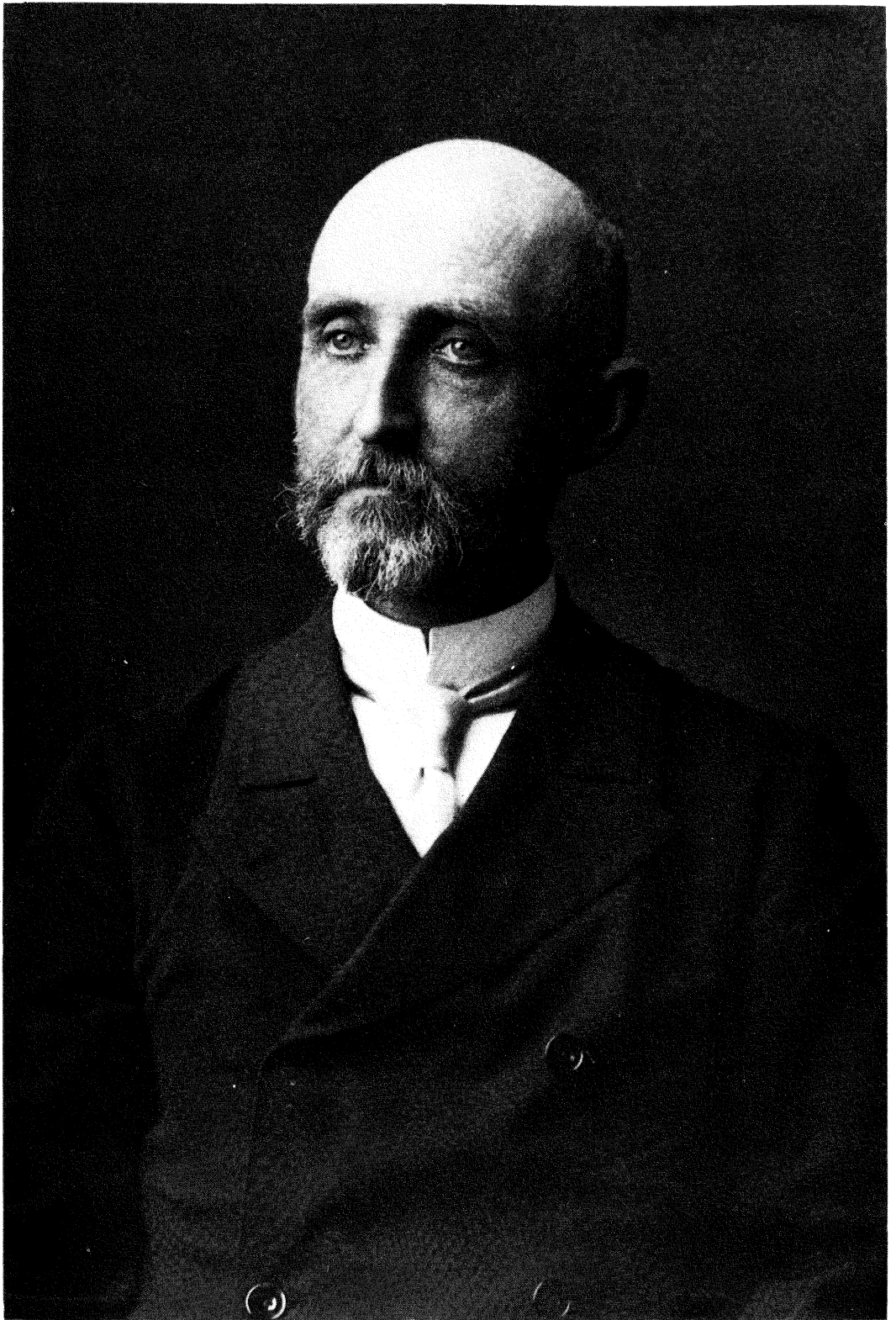

Preface

The year 1985 marked the 100th anniversary of Alfred Thayer Mahan's association with the Naval War College. On 16 October 1885, Secretary of the Navy William C. Whitney ordered Mahan to the Naval War College for duty, and, four days later, Mahan came to Newport to report to the president of the Naval War College, Rear Admiral Stephen B. Luce. During that time, Luce explained fully the work which he had in mind for Mahan, the writing of a book which would link national power with naval operations and provide the basis for a theoretical understanding. Mahan stayed in Newport only for a day and then went to New York where, while he remained assigned to the college, he did his research. Mahan did not take up residence in Newport until August 1886, by which time he had been ordered to succeed Luce as president of the college. A few days after Mahan's arrival, Luce, then Commander of the North Atlantic Squadron, gave the opening address to the new class. In it, Luce declared, "let us confidently look for that master mind who will lay the foundations of that [naval] science, and do for it what Jomini has done for the military science."

A dozen years later, Luce reflected on his own words and wrote next to that sentence in a copy of the published version of his address, "He appeared in the person of Captain A.T. Mahan, U.S.N."

There is no doubt that Mahan laid the foundation for a theoretical understanding of navies as well as contributed to the rise of the U.S. Navy to great power status. Curiously, however, there has been no complete bibliography of Mahan's published work. The 100th anniversary of the beginning of his theoretical work offers such an opportunity. Several important, but partial listings of Mahan's works have been published over the years. This bibliography collates, with additions and corrections, the bibliographies published in:

In addition, this list includes an attempt to identify translations and later editions, and to cross-reference reprints.

This bibliography is divided into eight sections. Each is denoted by a letter and each item within the section given a number. Mahan's characteristic method was to publish an article in a magazine, journal, or newspaper and then to republish it again with other articles in the form of a book. In order to trace the publishing history of these various items, a cross-reference system has been employed, using the letter of each section and the number of the item within that section.

The main divisions of this bibliography are:

- A. Books;
- B. Contributions to books written by others; Government documents;
- C. Mahan's writings collected and edited by others;
- D. Contributions to journals and magazines;
- E. Contributions to newspapers;
- F. Translated articles;
- G. Pamphlets.

The first law of bibliography is that, no matter how many years of labor go into a bibliographical reference work, on the day after publication someone will point out an imperfection, a variant, a missing title or edition. Readers with such information are asked to send it to the compilers of this list at the Naval War College, Newport, Rhode Island 02841-5010.

In most cases, Mahan asked the publisher to send him the flyleaves of his presentation copies so that he could sign them before the book was bound. 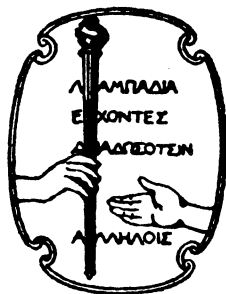

BULLETIN OF THE NORTH AMERICAN RE- VIEW, NOVEMBER, 1894.

The Editor takes pleasure in introducing to his readers in the November number of the REVIEW several new contributors, including Captain Alfred T. Mahan, U. S. N. ; Lord Charles Beresford ; Senator John L. Mitchell, of Wisconsin ; His Excellency the Japanese Minister at Washington ; and the Rev. Bishop Stephen M. Merrill.

The articles on the "Possibilities of Anglo-American Reunion" by Captain Mahan and Lord Charles Beresford cannot fail to attract wide attention.

Captain Alfred Thayer Mahan is a New Yorker by birth, and was appointed to the Naval Academy in 1856. In 1861 he was commissioned lieutenant, and lieutenant-commander in 1865. During 1870-71 he was attached to the New York Navy Yard, and in 1872 was commissioned commander. He was promoted to captain in 1885, and was made president of the War College in 1886. Last year he was appointed to the "Chicago," at present flagship of the European squadron. During his visit to England he was much fêted, and received many marks of distinction, including honorary degrees from both Oxford and Cambridge. Captain Mahan is accounted one of the greatest authorities on naval tactics in the world, and is best known by his two great works on the *Influence of Sea Power*. The first tells of the influence of that power *Upon History, 1660-1783*, and the second *Upon the French Revolution and Empire, 1794-1812*. Captain Mahan has also written *The Gulf and Inland Waters* and a *Life of Admiral Farragut*.

Lord Charles William Delapoe Beresford was born in 1846, and entered the Royal Navy at the age of thirteen. In 1875 he accompanied the Prince of Wales to India as naval aide-de-camp. At the bombardment of Alexandria in 1882 he commanded the "Condor," and greatly distinguished himself during the action both by his bravery and naval skill. For these services he was promoted to the rank of captain. He served in the Soudan under Lord Wolseley for the relief of General Gordon, and was in command of the Naval Brigade in the expedition across the desert.

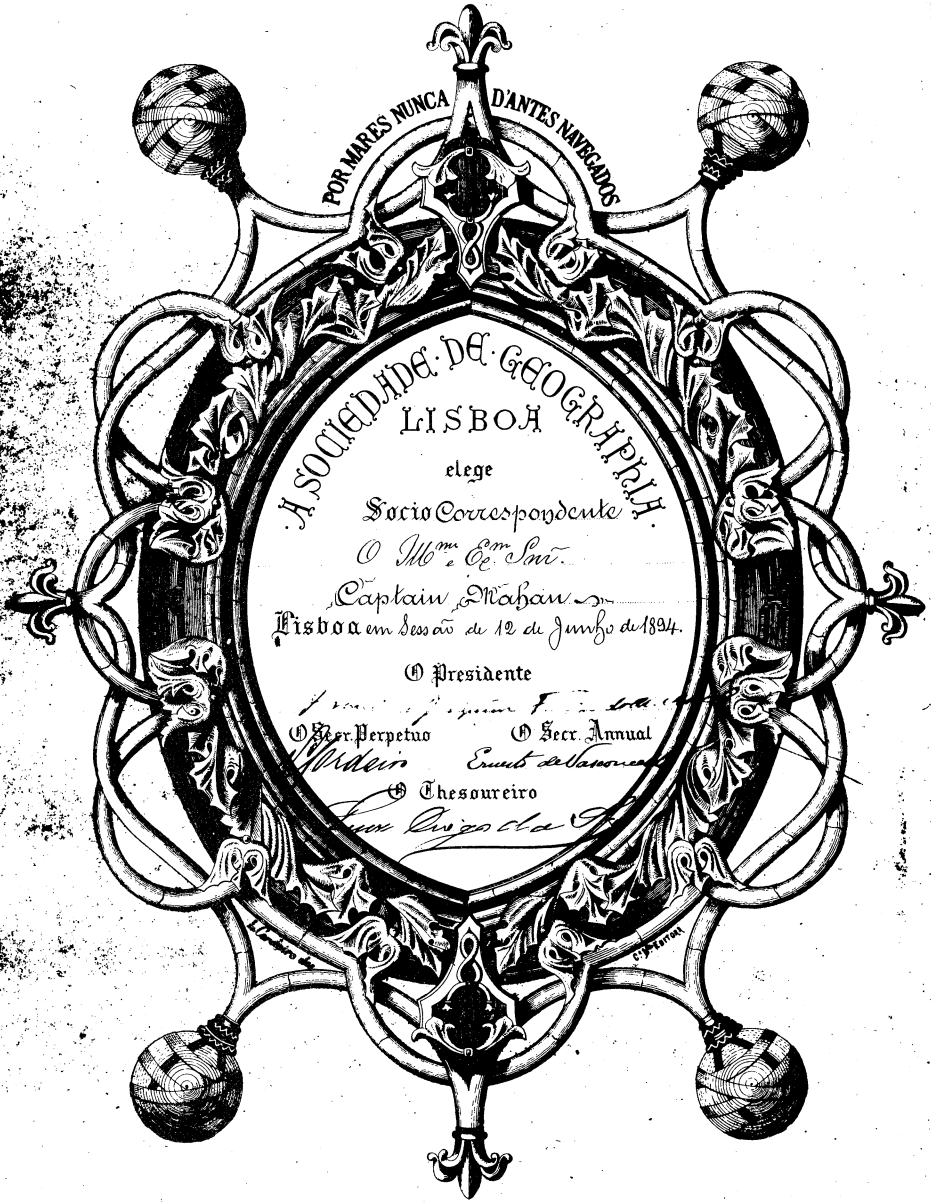

The war on the sea and its lessons.

(Der Krieg auf dem Meere [1898] und was er lehrt.)

Abschnitte IX. und X. Der Posten, der vor Cerveras Liegeplatz gestellt wurde, und die Ueberwachung der Bewegungen Cámaras.

Mit einer kurzen Uebersicht über den Stand der amerikanischen Streitkräfte im letzten Drittel des Monats Mai beginnt der neue Abschnitt. Das fliegende Geschwader kreuzte seit dem 22. vor Cienfuegos, während das um sein stärkstes Schiff geschwächte Geschwader Sampsons vor Havana Wache hielt. Die diesem beigegebenen Monitors waren ein nur mangelhafter Ersatz, und erst am 28. wurde das Fehlen der „Zowa“ durch das Hinzutreten der „Oregon“ wieder gut gemacht. Man erwartete, daß der Feind wahrscheinlich den Hafen von Cienfuegos anlaufen werde, ehe er sich nach der Nordküste Cubas wenden würde.

Am 19. ging dem Marineministerium die zwar glaubhafte aber noch unsichere Nachricht zu, daß das feindliche Geschwader in Santiago eingelaufen sei. Infolge von ungünstigen Zufälligkeiten hatte dies tatsächlich am 19. Morgens, unbemerkt von den amerikanischen Hilfskreuzern, stattfinden können. Der schnelle Hilfskreuzer „St. Louis“ hatte erst am 18. seinen Stand vor Santiago verlassen, nachdem es ihm dort unter Beistand eines Schleppdampfers gelungen war, das Kabel zwischen Santiago und Jamaica zu zerschneiden. Er war dann nach der kaum 50 Seemeilen östlich gelegenen Bucht von Guantanamo gelaufen, um auch dort dasselbe vorzunehmen, war aber aus dem inneren Theil der Bucht durch das Feuer eines kleinen Kanonenbootes und eines Geschüßes am Lande vertrieben worden. Das nur schwach armirte Schiff war dann mit seinem Begleitdampfer nordwärts gedampft, um Kohlen zu nehmen, hatte also zunächst am 19. die Ankunft Cerveras vor Santiago nicht bemerken können und war dann auch nicht zur Stelle, als Commodore Schley mit dem fliegenden Geschwader am 26. eintraf. Hätte es diesem berichten können, wie schwach die Verteidigungsmittel in Guantanamo Bay seien, so hätte Schley sicher ebenso, wie Sampson es später that, diesen Hafen als Kohlenplatz gewählt. Ohne diese Kenntniß hatte Schley am 26. für nöthig gehalten, daß wegen der Schwierigkeit des Kohlennehmens in der bewegten See vor Santiago das Geschwader mit seinem mit 3000 t Kohlen befrachteten Kohlendampfer den Rückweg nach dem 700 Seemeilen entfernten Key West antreten müsse.
